CIRCULAR


The Departmental Promotion Committee (DPC) meetings of various cadres falling in Group-C category is scheduled to be conducted shortly. Since, the instant matter was pending since 2019 due to status quo imposed by the Hon,ble Court in view of the objections filed by some employees which have now been vacated. Thus, the Departmental Promotion Committee (DPC) of group-C is to be held in phased manner.

Accordingly, to begin with, in the 1st phase, a tentative panel of eligible employees falling in Group- C category and are in zone of consideration of certain cadre's as per the annexure "A" who meets the prescribed criterion in terms of Shri Mata Vaishno Devi Shrine Board Employees (Recruitment and other conditions of Service), Bye Laws 1996, has been prepared and appended with this circular and also uploaded on the official website of Shrine Board for information of all employees of particular cadre. The said panel has been prepared on the basis of tentative seniority list issued upto 31.12.2020 and in the ratio of 1:3 i.e 03 employees in consideration against 01 post available.

In case of any clarification related to eligibility / qualification, the concerned employee (s) of particular cadre is/are advised to personally approach the Human Resources Department (HRD), Central Office, Katra on any working day between 11 AM to 1 PM within weeks time from the date of issuance of this circular alongwith the valid / original documents. Thereafter, a final panel of eligible employees shall be placed before the Designated Committee for consideration of promotions of group-C posts.


